General

1. Prior to this race, Stable Supervisor U. Nagadoo advised the Board that TOMORROW'S VISION (N. Batchameah) would be ridden in order to obtain the lead, if possible. This tactic change was disseminated to the public.

Starting Reports

1. LORD OF LIGHT (I. Taka) lost three lengths.
2. UNIVERSE BOSS (Y. Mauree) and SOCKEROO (M. Sonaram) lost two lengths, respectively.

Stewards Reports

1. CELESTIAL MAGMA (R. Boutanive) which raced wide in the early stages, was ridden aggressively from the jump and obtained the lead at the 1600m. Thereafter, this gelding overraced in the early and middle stages. In view of the performance of this horse, the Veterinary Surgeon was requested to examine.
2. UNIVERSE BOSS (Y. Mauree) raced detached throughout.
3. THE HITMAN (C. Goolgar) raced wide in the early stages. Subsequently, at the 1400m, THE HITMAN was carried out by TOMORROW'S VISION (N. Batchameah) which shifted out from the inside to race in a one-off position. Thereafter, at the 1300m, THE HITMAN was shifted in, in order to obtain a position on the rail.
4. LORD OF LIGHT (I. Taka) raced wide from the 500m.
5. OVERDOSE (S. Rama) raced wide around the turn and into the straight.
6. THE HITMAN (C. Goolgar) struck the rail at the 300m. Thereafter, this gelding hung in, in the straight.
7. At the 150m, BELLAGIO KING (V. Bundhoo) had to switch in to continue its run when racing onto the heels of CRIMSON GOD (B. Deenath).
8. Apprentice B. Deenath (CRIMSON GOD) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip down the shoulder of his horse while in the drawn position. Apprentice B. Deenath was issued with a warning.

9. Apprentice I. Taka signed an admission of guilt for a contravention of Rule 29.2.13, in that he struck the horse LORD OF LIGHT with the whip more than 7 times before the 150m. Accordingly, a penalty of a fine of Rs 2,000 was imposed.
10. Jockey S. Rama (OVERDOSE) appeared before the Board, was shown the patrol films of the race and advised against the practice of using his whip more than 7 times before the 150m. Jockey S. Rama was issued with a warning.
11. Jockey R. Boutanive signed an admission of guilt for a contravention of Rule 29.2.5, in that he struck the horse CELESTIAL MAGMA with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine of Rs 2,000 was imposed.
12. Apprentice M. Sonaram reported that SOCKEROO made an abnormal respiratory noise in the running. In view of this report, the Veterinary Surgeon was requested to examine.
13. Jockey S. Bhundoo reported that there was something amiss with SUMMERDALE in the running. In view of this report, the Veterinary Surgeon was requested to examine.

1. ITDAWNEDONME (S. Donohoe) lost many lengths.

Stewards Reports

1. Approaching the 1400m, ARNICA MONTANA (I. Taka) had to ease when awkwardly placed on the inside of SENOR DON (J. Bardottier). Jockey J. Bardottier signed an admission of guilt for a contravention of Rule 43.2.2, in that as the rider of the horse SENOR DON, he failed to ensure that he did not cause interference to ARNICA MONTANA approaching the 1400m. A suspension from riding in races for a period of one race meeting was imposed.
2. AMANDLA (N. Teeha) was ridden aggressively from its deep draw in order to test for the lead. Thereafter, this gelding raced fiercely between the 1300m and the 1100m when being restrained after being unsuccessful in its attempt to acquire the lead. Subsequently, at the 1000m, AMANDLA elected to race around the field and to the lead approaching the 900m.
3. Between the 1300m and the 700m, ARNICA MONTANA (I. Taka) had to be restrained off heels on a number of occasions whilst racing fiercely. As a consequence of this incident, approaching the 700m, ITDAWNEDONME (S. Donohoe) was carried out by MOON JUMPER (S. Bhundoo) which rolled out when awkwardly placed on the heels of ARNICA MONTANA and thereafter, approaching the 600m, CAROLINA REAPER (Y. Mauree) had to ease when awkwardly placed on the inside of MOON JUMPER, which rolled back in.
4. THE JAZZ SINGER (N. Marday) raced wide throughout.
5. ARNICA MONTANA (I. Taka) raced wide from the 400m.
6. At the 200m, Jockey J. Bardottier's whip became briefly entangled with his reins.
7. Apprentice J. Sophie used his whip down the shoulder of HUDSON RIVER, whilst in the drawn position. An inquiry has been opened.

Ramsamy approached the Board and advised that he was not fully prepared for the start and that he had been impeded by the foot of a handler. However, after reviewing the footage of the race, there was no evidence from the video footage which supported the version of Jockey K. Ramsamy. Accordingly, SONNENSTRAHL was maintained as a runner.
3. At the 1400m, CAPTAIN PERSIA (S. Donohoe) was momentarily inconvenienced when awkwardly placed between MANETHEREN (R. Perez) and LIQUID (I. Taka).
4. Jockey Perez used his whip down the shoulder of MANETHEREN, whilst in the drawn position. An inquiry has been opened.

5. SONNENSTRAHL (K. Ramsamy) raced wide from the 450m and was hanging in, in the straight.

 2. CITADEL (I. Taka) raced wide from the 400m.

3. SECRET CIRCLE (S. Donohoe) raced wide around the turn and into the straight. Thereafter, this gelding was hanging in from the 250m.
4. SPOTTED PEARL (B. Ecoignard) was hanging in from the 250m.
5. At the 150m, ROYAL ITALIAN (S. Rama) switched in to continue its run, however, this gelding was unable to obtain clear running and could not be fully tested in the concluding stages.
6. Apprentice I. Taka signed an admission of guilt for a contravention of Rule 29.2.13, in that he struck the horse CITADEL with the whip more than 7 times before the 150m. Accordingly, a penalty of a fine of Rs 2,500 was imposed.
7. In view of the performance of ARMED FORCE (C. Goolgar), the Veterinary Surgeon was requested to examine.

2. From the gates, THE GATEKEEPER (R. Joorawon) jumped first and led in the early strides of the race before being crossed at the 2300m and racing in the position behind the leader. Subsequently, this gelding overraced in the early and middle stages whilst being

restrained away from the fast early pace, which resulted in it obtaining the position three back on the inside at the 1900m. At the 900m, Jockey R. Joorawon elected to shift off the inside running rail into a one-off position and brushed with HOLY WARRIOR (D. Bheekary) when awkwardly placed on the inside of ALSHIBAA (C. Segeon). Subsequently, Jockey R. Joorawon tracked ALSHIBAA into the race between the 600m and the 400m before angling his mount outside of ALSHIBAA inside the 400m in order to make its run. At the top off the straight, THE GATEKEEPER struck the front and kicked clear of the field to win easily, breaking the course record.

3. Out of the gates, TWIST OF FATE (R. Perez) jumped moderately and overraced in the early stages whilst being restrained to a rearward position on the rail, initially three back on the inside. Between the 2000m and the 1900m, however, this gelding lost ground to the front runners which allowed sufficient room for two runners ahead of it to find the rail. This resulted in this horse racing in the position five back in last on the inside. At the 800m, as the pace quickened, TWIST OF FATE was ridden in order to keep pace with the field and was angled out turning for home. In the straight, however, this gelding which showed an inclination to lean in, made its run on the middle to the inside of the track and only finished its race off moderately to run third.
4. ALSHIBAA (C. Segeon) was carried out at the start. This gelding was subsequently restrained into a rearward position and after racing one-off for the first 300m of the race, was able to secure the running, at the 1900m, four back on the inside running rail, tracking THE GATEKEEPER. At the 1000m, Jockey C. Segeon elected to race around the field, briefly racing in a three deep position between the 900m and the 700m, before obtaining the lead whilst being positioned outside LUNAFACATION at the 600m, and crossing to the rail leaving the 300m. In the straight, this horse made its run toward the inside of the track and stayed on well to run second.
5. HOLY WARRIOR (D. Bheekary) was carried out at the start and jumped moderately. Thereafter, this gelding mustered speed in order to obtain the position outside the leader at the 2200m before being able to secure a position on the rail behind the leader at the 1900m. At the 700m, this horse was ridden to keep pace with the field. However, it was unable to keep in touch with the leaders and ran on steadily in the straight to finish fourth.
6. From the start, LUNAFACATION (M. De Oliveira) jumped out and was ridden aggressively in order to obtain the lead, which it did at the 2300m. Thereafter, this gelding overraced at various points in the early and middle stages which resulted in this race being

run at a fast pace. At the 900m, this horse was ridden in order to hold the lead, however, it was passed at the 600m, crossed at the 300m and ultimately compounded in the straight to run a distant fifth. In view of the performance of LUNAFACATION, the Veterinary Surgeon was requested to examine.

7. FAVOUR (I. Taka) injured its nose en route to the start. Subsequently, this gelding was examined by the Veterinary Surgeon and withdrawn.
8. An inquiry has been opened into Jockey D. Bheekary's whip use on HOLY WARRIOR in this race.

ADDITIONAL INFORMATION

1. Race 1, 3, 4, 5 and 8

The instructions for all riders in race 1, 3, 4, 5 and 8 were taken in the Board Room by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses unless stated in the report.

2. Race Meeting 26 – 3 September 2023 - Race 1 - The Younty Association of Petit-Raffray Cup

Trainer A. Sewdyal signed an admission of guilt for a contravention of Rule 40.4.2, in that he failed to ensure that HIGH VOLTAGE is presented in the paddock 12 minutes before the carded starting time of the Race.

3. Race Meeting 24 - 19 August 2023 – Race 3 - The Plaine Magnien Youth Group Cup

At an inquiry held at the Offices of the HRD on 28th August 2023, Jockey R Perez (ORANGE RED) was charged with a contravention of Rule 43.2.2, in that he failed to ensure that he did not cause interference to BELLA FIORINO (S. Donohoe) and YOHO MIST (S. Rama) at the 1200m in race 3, run at the Champ De Mars racecourse on 19th August 2023.

Jockey Perez pleaded guilty to the charge and was accordingly found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one (01) Race Meeting and a fine of Rs.10,000.

Jockey Perez has the right of appeal against the severity of the penalty imposed.

4. Race Meeting 24 - 19 August 2023 – Race 5 - The Rose-Belle Profession Women Association Cup

At an inquiry held at the Offices of the HRD on 28th August 2023, Jockey S Rama (CLOUD SEEDER) was charged with a contravention of Rule 43.2.2., in that he failed to ensure that he did not cause interference to TRAVELIN MAN at the 150m in Race 5 run at the Champ De Mars race course on 19th August 2023.



Jockey S Rama pleaded guilty to the charge and was accordingly found guilty as charged. After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one (01) Race Meeting.

Jockey S Rama has the right of appeal against the severity of the penalty imposed.

Race Meeting 24 - 19 August 2023 – Race 8 - THE <<FORCE VIVE DE CAMP DIABLE>> CUP

At an inquiry held at the Offices of the HRD on 28th August 2023, Jockey D Bheekary (TORO BRAVO) was charged with a contravention of Rule 43.2.2., in that he failed to ensure that he did not cause interference to TRIP TO THE SKY leaving the 1300m in Race 8 run at the Champ De Mars race course on 19th August 2023.

Jockey D Bheekary pleaded guilty to the charge and was accordingly found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a suspension from riding in races for one (01) Race Meeting.

Jockey D Bheekary has the right of appeal against the severity of the penalty imposed.

Race Meeting 24 - 19 August 2023 – Interview after Race 9

At an inquiry held at the Offices of the HRD on 30th August 2023, Trainer R Maingard was charged with a contravention of Rule 81.1.25, in that, in a post-race interview after the running of race 9, at the Champ De Mars Racecourse on 19 August 2023, he conducted himself in a manner which might have the effect of discrediting horseracing or bringing into disrepute horseracing or the HRD.

Trainer R Maingard pleaded not guilty to the charge, however, was found guilty as charged.

After considering the evidence in this matter, the Inquiry Board imposed a penalty of a fine of Rs.5,000.

Trainer R Maingard has the right of appeal against the charge as well as the penalty imposed.
