1. Prior to the running of this race, Assistant Trainer U. Nagadoo advised the Board that his instructions to Jockey B. Bhaugeerothee were to ride MASTEROFALLISURVEY in a forward position. This change of tactic was disseminated to the public.

Starting Reports

1. MASTEROFALLISURVEY (B. Bhaugeerothee), HIGH VOLTAGE (K. Ramsamy) and BIG SMOKE (G. Aucharuz) were slow.

Stewards Reports

- 1. THE HITMAN (C. Segeon) had a tendency to hang in.
- 2. Jockey B. Bhaugeerothee (MASTEROFALLISURVEY) appeared before the Board, in relation to his riding between the 400m and 270m, and was shown the patrol films of the race. He stated that he began to ride his horse from the 400m, however could not continue to do so as AFRICAN ROCK (B. Sooful) was in front of him and THE HITMAN (C. Segeon) was alongside and he had to steady his horse and due to this difficult position, his horse shifted out and brushed with THE HITMAN near 250m. After taking into consideration the given circumstances, Jockey B. Bhaugeerothee has been advised to ride his horses carefully and not interfere with another horse in a race
- 3. Jockey M. Rashpassing (RED ROCK CANYON) reported that his horse was keen in the running between the 1400m and the 1200m.
- 4. Jockey G. Aucharuz (BIG SMOKE) reported that his horse kept on changing its leg. In view of this report, the Veterinary Surgeon was requested to examine.

Starting Reports

1. SYLVAN THEATER (R. Joorawon) began awkwardly and was slow.

Stewards Reports

1. COURTROOM MAGIC (K. Ramsamy) was ridden from the 600m to keep pace with the field and then dropped out from the 350m. Further, Jockey K. Ramsamy reported that the



horse did not stride out freely in the running. In view of this report, the Veterinary Surgeon was requested to examine.

- 2. Jockey G. Aucharuz (ROYAL VIRTUE) appeared before the Board and advised against the practice of using his whip down the shoulder of his horse while in the drawn position and on consecutive strides in the running. Jockey G. Aucharuz was issued with a warning.
- 3. A review of riding the Jockey K Ramsamy (OURTROOM MAGIC) will be held.
