- 1. Approaching the 600m, FORT MCHENRY (P. Horil) was steadied while racing on the inside of WAIMEA (R. Joorawon). Jockey P. Horil appeared before the Board and was shown the patrol films of the race and advised to be careful when riding his horse in an insufficient gap.
- 2. Near the 100m, WAIMEA (R. Joorawon) put in an awkward stride.
- 3. FORT MCHENRY (P. Horil) shifted ground outward under the use of the whip.
- 4. Whilst reviewing the race, it was observed that Jockey A. Correira Da Silva (MOON JUMPER) pulled the earplugs of the horse approaching the 400m and therefore it did not carry the equipment in terms of the Rules. Trainer A. Rahmathulla and Jockey A. Correira Da Silva appeared before the Board, were shown the patrol films of the race, and interviewed in this regard. Subsequently, Jockey A. Correira Da Silva signed an admission of guilt for a fine of Rs 5,000 was imposed on him.

ADDITIONAL INFORMATION

1) Race Meeting 15 - Race 8 – 10 August 2024 - The Poste La Fayette Association Cup

Trainer S. Mahadia signed an admission of guilt for a contravention of Rule 80.1.24 in that he conducted himself in an improper manner at the time of Weighing in of the Jockeys after the conclusion of race 8. Accordingly, a penalty of a fine of Rs 20,000 was imposed.

2) Race Meeting 17 – Race 2 – 24 August - The Grand River South East Association Cup

Trainer C. Ramdin signed an admission of guilt in that he failed to inform the shoeing on his horse, THE GYPSY KING, within the stipulated time limit. Accordingly, a penalty of a fine of Rs 5,000 was imposed.

3) Race Meeting 16 – Race 5 - 18 August 2024 - The Ecroignard Association Cup

Jockey K.Ramsamy was questioned in relation to his handling of COURTROOM MAGIC in Race 5 of Meeting 16 ran on Sunday August 18, 2024. Asked to why he did not make any attempt to secure the fence in front of ROYAL VIRTUE despite his mount taking a better jump than the latter, he explained that he was strictly instructed by his trainer not to bounce the horse at start and to race one off the fence as COURTROOM MAGIC is known to be a galloping horse. He stated that his trainer did not want the horse to be boxed in or held up at any stage of the race. He also added that, as he reported after the race, the horse did not stride out freely in the running and was ridden from the 600m to keep pace with the field and then dropped out from the 350m. Trainer Raj Ramdin confirmed those instructions but in view of the horse's performance, he was however reprimanded to ensure that his horses are competitive in their races.

4) Race Meeting 12 – Race 8 – 20 July 2024 – La Journee Mondiale de Prevention de la Novade Cup

Jockey S. Rama (LINE OF DUTY) and Trainer A. Sewdyal appeared before the Board in relation to the riding of the Jockey in the early stages of the race when it appeared that leaving the 1500m, Jockey S. Rama, after a slow start, allowed his horse to move forward and take the lead near the 1300m. Jockey S. Rama advised that the horse being a puller, he did not want to fight with LINE OF DUTY and let it roll at its own pace and the reason for electing to do so was the reduction of the pace by GONNABEALRIGHT (C. Segeon) which resulted in MENELAUS (B. Bhaugeerothee) losing pace and as he following MENELAUS, he elected to move out from behind of MENELAUS. Trainer A. Sewdyal concurred with the statements of Jockey S. Rama and expressed his satisfaction with the decision of the Jockey to not fight with



his horse and allow it to roll along. After a review, Stewards decided not to proceed further in the matter.
