2. There was a light and medium shower prior to the start of the first race.

**Starting Reports**

1. BIG SMOKE (M. Sonaram) was slowly away by three lengths.
2. UNIVERSE BOSS (R. Boutanive) was slowly away.

**Stewards Reports**

1. BIG SMOKE (M. Sonaram) stopped galloping at around the 1000m and did not finish the race. In view of the performance of this horse, the Veterinary Surgeon was requested to examine.
2. Passing the 600m, THE HITMAN (C. Segeon) drifted in, inconveniencing HIGH VOLTAGE (G. Aucharuz) and causing the latter to check. Jockey C. Segeon appeared before the Board and was shown the patrol films of the race with regards to this incident and he was issued with a reprimand accordingly.
3. CONSTITUTIONAL (K. Ramsamy) and RED ROCK CANYON (M. Rashpassing) finished detached in the race. Trainer S. Hurchund was advised to ensure that his horses run competitively.

### **General**

1. Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses.

### **Starting Reports**

1. No report.

### **Stewards Reports**

1. R. Joorawon (DAGOTIERE) took a hold soon after jumping out and chose to settle his horse on the inside.
2. JAMES PETER (K. Ramsamy) drifted out passing the 1000m and travelled detached from the field. In view of the performance of JAMES PETER, the Veterinary Surgeon was requested to examine.
3. Passing the 1000m, CAPKUTA (A. Correira Da Silva) came across AL JAZEERA (B. Bhaugeerothee), causing Jockey B. Bhaugeerothee to take hold of his horse momentarily. CAPKUTA further shifted in passing the 700m and caused a similar inconvenience to AL JAZEERA. Jockey A. Correira Da Silva was severely reprimanded for riding an erratic race.
4. Jockey B. Bhaugeerothee (AL JAZEERA) was severely reprimanded for his use of whip in the last 300m, when he used his whip on the right continuously, causing the horse to drift out five off the rails.
5. DAGOTIERE (R. Joorawon) drifted out under the use of the whip in the last 150m.

6. AL JAZEERA (B. Bhaugeerothee) drifted out under the use of the whip in the last 100m.
7. CIDER HOUSE RULES (B. Sooful) drifted in under pressure in the final stages of the race.
8. Jockey A. Correira Da Silva (CAPKUTA) was questioned regarding the poor performance of his horse. He explained that despite his efforts, his mount failed to race further upfront and did not respond to his urgings when the pace quickened. Trainer A. Rahmathullah was also questioned and he was of the opinion that CAPKUTA did not like the going. The Board noted the explanations of Jockey A. Correira Da Silva and Trainer A. Rahmathulla.
9. Jockey R. Joorawon (DAGOTIERE) reported to the Course Medical Officer, who stood him down for the remainder of the race meeting

2. Jockey G. Aucharuz (BELLAGIO KING) did not persevere in the last 300m of the race. BELLAGIO KING was subjected to Veterinary examination.
3. WAR MEDAL (R. Boutanive) hung in, in the straight.
4. ARLINGTONS REVENGE (M. Sonaram) finished detached in the race and was subjected to Veterinary examination.
5. Jockey G. Aucharuz (BELLAGIO KING) and Trainer N. Rawat were questioned with regards to the running and riding of BELLAGIO KING. Jockey G. Aucharuz stated that he was instructed to ride with the intention to lead and in doing so, he tried to get a position in front. However, BELLAGIO KING was not responding, due to which, he was caught wide in the field. However, Jockey G. Aucharuz still persisted with trying to lead but BELLAGIO KING did not respond to his urgings before weakening badly leaving the 400m. Trainer N. Rawat conveyed his dissatisfaction with regards to the run of his horse and stated that his horse had to be ridden from the front and he felt that the track condition was not suiting the run of the horse.

1. Jockey M. Sonaram (BELLA FIORINO) was severely reprimanded for shifting out soon after the start and inconveniencing the horses on its outside viz CULTURE TRIP (G. Aucharuz) and SWAGGER JAGGER (B. Bhaugeerothee).
2. Jockey G. Aucharuz (CULTURE TRIP) stopped riding in the last 300m of the race. Jockey G. Aucharuz reported that the horse was lame. In view of this report, the Veterinary Surgeon was requested to examine.
3. Jockey B. Sooful (CANFORD LIGHTS) reported that his horse was hanging out in the straight. After viewing the patrol films of the race, Jockey B. Sooful signed an admission of guilt for using his whip on the right, allowing the horse to drift out, inconveniencing BELLA FIORINO (M. Sonaram), which was travelling on his outside. Accordingly, a penalty of a fine of Rs 3,000 was imposed on him.

Unfortunately, he was caught on the outside of three other horses, which left him with no other option but to pass them and sit in front. Additionally, he expressed his discontent about the riding of COLOUR MY FATE (R. Kulloo) which challenged him on the outside to lead. Trainer V. Ruhee expressed his consent with regards to explanation given by Jockey C. Segeon.
