## JOCKEY CHANGES

Race 2, Jockey B Jacobson was replaced by Jockey J Bardottier on QUEST FOR GOOD.

Race 3, Jockey B Jacobson was replaced by Jockey J Allyhosain on TIGER'S BOND.

Race 7, Jockey B Fayd'herbe was replaced by Jockey S Rama on BOLLINGER.

Race 7, Jockey L Goomany was replaced by Jockey J Allyhosain on PARTNER IN CRIME.

Race 8, Jockey L Goomany was replaced by Jockey M P De Oliveira on LOCK DOWN.

#### **Stewards' Reports**

At the start, DOUBLETHINK (I Taka) brushed the gates and then took the running of FORT COMMANDER (S Bhundoo).

Leaving the 1300m, SERGEANT YORK (M Rashpassing) drifted out for a few strides.

ONE DAY OR DAY ONE (N S Batchameah) hung out in the straight. Trainer SP Nagadoo has been advised to correct this trait of the horse.

App I Taka (DOUBLETHINK) and Jockey N Marday (FASSI) have been issued with a reprimand for continual use of whip in their right hand as their horses shifted out.

#### **Stewards' Reports**

At the start, KING OF COLTS (A L Da Silva) brushed the gates and FRENCH REBEL (N Teeha) was slow.



At the start, INSTINCTIVE POWER (G D Aucharuz) drifted in, causing QUEST FOR GOOD (J Bardottier) to brush with KING OF COLTS (A L Da Silva).

Near the 600m, QUEST FOR GOOD (J Bardottier) and SHESH BESH (B Fayd'herbe) brushed.

Jockey GD Aucharuz was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he used his whip more than once on consecutive strides on his horse, INSTINCTIVE POWER. Consequently, a penalty of suspension from riding in races for one (01) Race Meeting was imposed on him, that is, for 5<sup>th</sup> November 2022. He was reminded of his right to appeal.

An inquiry has been opened into the riding of Jockey GD Aucharuz (INSTINCTIVE POWER).

**293 - (13h40) - THE FESTIVAL OF LIGHTS CUP - (0-20) - ABT. 1500M (6 Runners)**

**Stewards' Reports**

At the start, TIGER'S BOND (J Allyhosain) was slowly away and lost five (5) lengths and trailed the field until about 500m. In view of the behaviour of the horse, it has been suspended for 7 days, after which it will be required to pass a Barrier Trial to the satisfaction of the Stewards.

At the start, CARLTON HEIGHTS (J Da Silva) jumped awkwardly inwards and brushed with ENIGMA CODE (I Taka) who in turn brushed MASTEROFALLISURVEY (N S Batchameah).

Passing the 1300m, ENIGMA CODE (I Taka) dipped and shifted out.

Near 300m, CRUSHING FORCE (N Marday) was eased off the heels of CAPKUTA (G D Aucharuz).

MASTEROFALLISURVEY (N S Batchameah) lugged in, in the straight.

CAPKUTA & CRUSHING FORCE – Not striding out.

**Stewards' Reports**

It rained before the start of the race as well as during the running of the race.

Leaving the stalls, LUNAFACATION (I Taka) was squeezed out.

LUNAFACATION (I Taka) lugged in, in the straight. The horse was referred to the Veterinary Surgeon.

Jockey L Goomany (KAYDENS PRIDE) reported that the running of his horse was affected by kickbacks.

MARSHALL FOCH – Lamé near fore.

BACKPACKER – Small injury left hind heel.

THE IT FACTOR – Lamé off fore.

LUNAFACATION – Lamé off fore, bled one nostril, 30 days suspension confirmed.

KAYDENS PRIDE – No abnormalities detected.

**295 - (14h50) - THE DIWALI RANGOLI, FESTIVAL OF COLOURS CUP - Benchmark 61 - ABT. 1365M (6 Runners)**

**Stewards' Reports**

TRIPPI'S EXPRESS (A L Da Silva) was led to the start.

Jockey L Goomany reported that FOOTY GOAL brushed the gates.

ARIZONA SILK (I Taka) travelled wide for most part of the race.

Passing over the 450m crossing, FOOTY GOAL (L Goomany) was unbalanced.



Jockey L Goomany (FOOTY GOAL) appeared to have eased his horse in the concluding stages of the race, however, since the horse was reported to have returned lame after the race, no action has been initiated against the Jockey.

**Veterinary Surgeon's Report**

FOOTY GOAL – Injured off fore heel, lame off fore and injury inside of nostrils.

PORTICO – No abnormalities detected.

After the running of Race 5, Jockey D Schwarz (EMERALD BAND) and Jockey G D Aucharuz (PORTICO) reported that they found the track between the 1200m and 900m slightly slippery. Consequently, Jockeys engaged in race 6 were informed of same.

**296 - (15h25) - THE MARYSE JUSTIN MEMORIAL CUP - G1 - ABT. 1400M (WFA) (4 Runners)**

**Stewards' Reports**

FROSTED GOLD (B Fayd'herbe) proved difficult to be loaded.

Near 1100m, FROSTED GOLD was ridden around TRIPLE FATE LINE (A L Da Silva) and near 900m shifted in and took the running of TRIPLE FATE LINE who was eased off the heels of FROSTED GOLD (B Fayd'herbe).

Jockey B Fayd'herbe was interviewed and subsequently he signed an admission of guilt whereby he contravened Rule 208(d), in that, whilst riding the horse FROSTED GOLD, he failed to ensure that he did not cause interference to other horses.

Accordingly, a penalty of suspension from riding in race for a period covering two (2) Race Meetings was imposed. Therefore, his license will stand suspended from 29<sup>th</sup> Oct 2022 to 05<sup>th</sup> Nov 2022 (both days inclusive).

Jockey B Fayd'herbe (FROSTED GOLD) reported this his horse brushed the rails near 400m.

**Veterinary Surgeon's Report**

FROSTED GOLD – Injury right flank requiring suturing.



**297 - (16h00) - THE JUGNANUN MANI MOTAH MEMORIAL CUP - Benchmark 41 - ABT. 1500M (7 Runners)**

**Stewards' Reports**

At the start, MAN OF PROPERTY (R K Chumun) and CLOUD SEEDER (J Da Silva) brushed.

Soon after the start, PARTNER IN CRIME (J Allyhosain) commenced to shift in, carried DESERT ILLUSION (GD Aucharuz) inwards who brushed with BESTDAY OF MYLIFE (M P De Oliveira) who was awkwardly placed on the heels of CASTLE OF GLASS (N Teeha) and eased. PARTNER IN CRIME continued to shift in, tightened DESERT ILLUSION (G D Aucharuz), whose rider had to take evasion action. Later PARTNER IN CRIME took the running of DESERT ILLUSION.

An inquiry will be opened into this interference.

PARTNER IN CRIME (J Allyhosain) lugged-out in the concluding stages of the race.

An inquiry will be opened into the loading and jumping out of PARTNER IN CRIME (J Allyhosain) and MAN OF PROPERTY (R K Chumun) from incorrect stalls.

MAN OF PROPERTY & DESERT ILLUSION – No abnormalities detected.

**298 - (16h45) - THE FESTIVAL OF SWEETS & SAVOURIES CUP - Benchmark 31 - ABT. 1400M (8 Runners)**

**Stewards' Reports**

At the start, EDGE OF THE SUN (S Rama) began awkwardly.

At the start, LOCK DOWN (M P De Oliveira) shifted in slightly causing a chain reaction where GORDONSTOUN (J Allyhosain), SYDS LIASON (I Taka), EDGE OF THE SUN (S Rama), and NEVIL MU (B Bhaugeerothee) shifted in. At the same time, MOROCCAN RETREAT (G D Aucharuz) shifted out and jostled with NEVIL MU (B Bhaugeerothee) who was already shifting in.



Soon after the start, LOCK DOWN (M P De Oliveira) drifted in causing GORDONSTOUN (J Allyhosain), to shy inwards and brush with MOROCCAN RETREAT (G D Aucharuz) and then ricocheted outwards and was awkwardly placed on the heels of LOCK DOWN (M P De Oliveira) and steadied.

In the concluding stages, MOROCCAN RETREAT (G D Aucharuz) was eased off the heels of HIGH VOLTAGE (J Da Silva).

**Veterinary Surgeon's reports**

No report.

**Other comments/Explanations:**

1. Pre-race blood specimens were taken from all starters which were reported to be negative.
2. In all races, all the riders were weighed in.
3. All the winners were selected for the taking of specimens for analysis.
4. All riders were breathalysed and cleared to ride.
