JOCKEY CHANGES

Race 5, Jockey B Fayd'herbe was replaced by Jockey G D Aucharuz on DESERT BOY.

Race 6, Jockey B Fayd'herbe was replaced by Jockey G D Aucharuz on SPECIAL BLEND.

Race 7, Jockey B Fayd'herbe was replaced by Jockey S Rama on WELL CONNECTED.

Race 8, Jockey G D Aucharuz was replaced by Jockey J Allyhosain on DO OR DARE.

281 - (12h30) - THE PANDIT SAHADEO, ALSO KNOWN AS DAJEE RAMA, MEMORIAL CUP - (0-15) - ABT. 1650M (7 Runners)

Stewards' Reports

Jockey G D Aucharuz (KALI'S CHAMP) carried 0.5kg over the carded weight and weighed out at 58kg.

At the start, BELLS APOSTLE (I Taka) shifted outwards and was then corrected. SLIGHTLY SCOTTISH (S Rama) was slowly away and lost about two (2) lengths.

Near 1400m, SUPREME ELEVATION (NS Batchameah) shifted in to gain a position along the rails and caused BYPASS (R Boutanive) to be eased.

Leaving the 900m, SLIGHTLY SCOTTISH (S Rama) was ridden to obtain a forward position, travelled wide near the 450m and then trailed in the straight.

Near the 700m, MIDNIGHT ORACLE (B Jacobson) was eased first from SLIGHTLY SCOTTISH (S Rama) and then BYPASS (NS Batchameah).

Near the 600m, KALI'S CHAMP (G D Aucharuz) and SLIGHTLY SCOTTISH (S Rama) brushed.

Near the 300m, SLIGHTLY SCOTTISH (S Rama) was eased off the heels of KALI'S CHAMP (G D Aucharuz).

At the start, OVERDOSE (J Da Silva), BELLAGIO KING (J Bardottier) and EXECUTIVE DECISION (I Taka) brushed.

THE HITMAN (A L Da Silva) was slowly away and lost about two (2) lengths.

Prior to coming into the home turn for the first time, EXECUTIVE DECISION (I Taka) was keen and was steadied.

Near 600m, EXECUTIVE DECISION (I Taka) brushed the rails.

THE HITMAN (A L Da Silva) hung in during the race and near the 400m, shifted across EXECUTIVE DECISION (I Taka) who was steadied and near the 100m, THE HITMAN was inclined to lean in onto HEART OF DARKNESS (J Allyhosain). The horse was referred to the Veterinary Surgeon.

At the start, HUYSTEEN (I Taka) planted and lost considerable ground. In view of this behaviour of HUYSTEEN, the horse has been suspended for seven (7) days after which, it will be required to pass a Barrier Trial to the satisfaction of the Stewards.

At the start, DONNAN (K Ramsamy) jumped awkwardly, brushing the gates.

In the straight, ACTION PACKED (B Fayd'herbe), GUNSTON (A L Da Silva) and CREATION (N Marday) lugged in.

Stewards' Reports

At the start, PROFICIENT (J Allyhosain) was slow. YOHO MIST (J Da Silva) jumped awkwardly inwards. JACLAC (B Fayd'herbe) brushed the gates.

When afforded an opportunity, Jockey J Allyhosain (PROFICIENT) advised that his instructions were to "lead" if possible, otherwise be in second position. The Jockey further advised that the horse did not take a good start and was then covered by the other horses, therefore, he could not position his horse as instructed. He added that the pace was slow in the early stages and near 1200m, dipped out and carried AFRICAN ROCK (B Jacobson) outwards and his horse ran keen and then in the straight, the horse hung in. The horse was referred to the Veterinary Surgeon.

Jockey G D Aucharuz was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he struck the horse, GONTRAVELIN, with his whip more than once on consecutive strides in the running. Consequently, a penalty of a fine of MUR 4500 has been imposed on him. The Jockey has been reminded of his right to appeal.

After the race, Jockey B Fayd'herbe (JACALAC) who had hit his leg on the gate while jumping out, was examined by the Medical Doctor who certified the Jockey unfit to ride in the remaining races of the day. Consequently, a change of rider was permitted. The Jockey will be required to provide a fitness certificate from the Medical Doctor before riding again.

At the start, KINGSMAN (N Marday) began awkwardly.



Coming through the 450m crossing, CANDLE COVE (J Allyhosain) broke down and was immediately eased out of the race and stopped near 300m. This resulted in CAPTAIN GARETT (I Taka) who was on the inside of CANDLE COVE (J Allyhosain) and TRYING TIMES (S Rama) which was positioned behind CANDLE COVE (J Allyhosain) having to be eased to avoid CANDLE COVE.

Jockey G D Aucharuz was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he struck the horse, DESERT BOY, with his whip more than once on consecutive strides in the running. Consequently, a penalty of a fine of MUR 5000 has been imposed on him. The Jockey was reminded of his right to appeal.

While leaving the gates, STOPALLTHECLOCKS (N Marday) brushed the gates. YOUR PACE OR MINE (K Ramsamy) jumped awkwardly.

Near 400m, SEATTLE KID (S Rama) was eased off the heels of AFDEEK (J Allyhosain) which resulted in SPECIAL BLEND (G D Aucharuz) being eased off the heels of SEATTLE KID.

Near 150m, SEATTLE KID (S Rama) hung in due to which SPECIAL BLEND (G D Aucharuz) raced in restricted room.

Jockey S Rama (SEATTLE KID) has been issued with a reprimand for allowing his horse to shift outwards while ridden under the use of the whip in the final 100m.

Jockey J De Souza was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he struck the horse, BLACKBURN ROC, with his whip more than once on consecutive strides in the running. Accordingly, a penalty of a fine on MUR 3500 was imposed. The Jockey was reminded of his right to appeal.

Jockey J Bardottier (TIGER'S ROCK) was 0.5kg overweight and weighed out at 61kg.

App N S Batchameah (STRAIGHT) claimed 2.0kg out of his 3.0kg allowance & weighed out at 56.5kg.

GOOD BUDDY (J Allyhosain) was led to the start.

At the start, TIGER'S ROCK (J Bardottier) stumbled. WELL CONNECTED (S Rama) began awkwardly and ILLICIT KISS (A L Da Silva) and GANG LEADER (N Teeha) brushed.

GANG LEADER (N Teeha) raced keen in the early part of the race and near the 1200m, drifted wide.

Jockey G D Aucharuz (COUP FOR LUTE) hit his right leg on the gate and was referred to the Medical Officer and was certified unfit to ride in the remaining races of the day. Consequently, a change of rider was permitted. The Jockey will be required to provide a fitness certificate from the Medical Doctor before riding again.

Jockey GD Aucharuz was found in contravention of Rule 147(6)(a)(i), in that, prior to the 100m, he struck the horse, COUP FOR LUTE, with his whip more than once on consecutive strides in the running. A penalty of a suspension from riding in races for one (1) Race Meeting has been imposed, that is, 29th October 2022. The Jockey has been apprised of his right to appeal.
