He advised the Board that his horse jumped the crossing, losing position and then LOVE ME AGAIN was laying out which resulted in this horse travelling wide in the final turn. He further advised his horse ran unsettled and it was racing after a long lay-off. The explanations of Jockey N. Marday was noted.

General

- Prior to the commencement of this race, the instructions for all riders were taken by the Stipendiary Stewards. In this regard, each of the instructions matched the racing pattern of the horses.
- 2. ROMANUS (P. Horil) played up violently in the stalls, ducked under the gates, bolted and in the process Jockey P. Horil was injured.
- 3. In view of ROMANUS bolting, the runners were taken out from the Starting Stall and the filed was reloaded after ROMANUS was apprehended. This resulted in the delay of the start of the race. Subsequently, ROMANUS was withdrawn.
- 4. ALPENHORN (M. Ribeiro) was examined by the Veterinary Surgeon prior to being reloaded.

Starting Reports

- 1. DAYLA VISTA (R. Oodith) jumped awkwardly.
- 2. CASIMIRO (S. Rama) was slow.

Stewards Reports

- In view of the Starting Report, the starting stall certificate for ROMANUS (P. Horil) has been withdrawn. This horse has been suspended by the Stipendiary Stewards for seven days after which, it will be required to complete a jump out in a barrier trial to the satisfaction of the Stipendiary Stewards.
- Passing the 400m, CASIMIRO (S. Rama) broke his right-fore leg and fell, dropping its rider. CARINO BELLO (J. Bardottier) and DAYLA VISTA (R. Oodith) which were following, collided with fallen horse and fell, dislodging their respective riders.
- 3. Soon after entering the straight, Jockey A. Roy (SPECIAL FORCE) lost his right stirrup, after which the left stirrup was out. Jockey A. Roy seemed to have lost balance and fell off his mount. An inquiry has been opened into this incident.
- 4. Jockeys J. Bardottier, S. Rama, P. Horil, R. Oodith and A. Roy were declared medically indisposed for the rest of the race meeting.



5. In view of the fall suffered by CARINO BELLO & DAYLA VISTA, both the horses have been suspended for a period of 14 days and until passed fit to race by the Veterinary Surgeon.

ADDITIONAL INFORMATION

- 1. Jockey M. Ribeiro, the declared rider for today's race meeting, was requested to provide a urine sample in terms of the Rules of Racing, however, he initially failed to do so as per the prescribed procedures, but later, provided another one when asked to do so. An inquiry has been opened into this matter.
- 2. On the Veterinary Surgeon's advice, the horse ETCHED IN BLUE has been found repeatedly lame after races and scratched several times after nominations, therefore the horse has been suspended for 30 days (effective from 07 Aug 24), after which it will be required to pass a Barrier Trial to the satisfaction of the Stipendiary Stewards.

3. Race Meeting 13 – 27 July 2024 Race 6, The Mazavaroo Cup

Jockey R. Oodith signed an admission of guilt for a contravention of Rule 43.2.2 in that as the rider of the horse ADITI, he failed to ensure that he did not cause interference to WAR MEDAL (K. Ramsamy) approaching the 1300m. A suspension from riding in races for a period of one race meeting and fine of Rs 10,000 was imposed effective 24th August 2024.

4. Race Meeting 13, 27th August 2024; Race 02, The Golden Age Senior Citizen Association Cup

Jockey S Bundhoo (DUKE OF ABERCORN) signed an admission of guilt for a contravention of Rule 43.2.3, in that, as the rider of the horse DUKE OF ABERCORN, he failed to take all reasonable and permissible measures while riding the horse to ensure that he ride to instructions given to him by his Trainer. A suspension from riding in races for a period of two Race Meetings was imposed, effective on 18th and 24 August 2024.
