Jockey N Marday (SEOUL) was questioned with regard to him travelling wide for most part of the race. The Jockey explained that his horse jumped well and was caught wide outside of NIMITZ (N Teeha) and did not want to break the stride of the horse and therefore let it run as he found him. It was put to the Jockey that in this race, his horse travelled extra ground as compared to any other runner and it was accepted that the horse was out of contention from the 600m. Jockey N Marday had reported that his horse was not striding out but the veterinary examination did not reveal any abnormality.

Apprentice I Taka (SNOWY MOUNTAIN) has been reprimanded for allowing his horse to shift ground outward in the straight under the use of the whip.

At the start POETIC LICENSE (N Marday) was slow to get into stride, losing about 3 to 4 lengths.

When afforded an opportunity, with regards to the comparative performance of NEW ABBEY in this race which the horse won as compared to its previous run on the 13th August 2022. Trainer S Hurchund conveyed that today this mare's behaviour was better as she was settled in her stall as the horse was loaded last whereas the horse was loaded earlier for the earlier two times and the horse was restless in her stall. He advised that he did not fancy her this



time. He further advised that last time NEW ABBEY had not finished badly and was about 4.5 length behind the winner. In view of the explanation, the matter was closed.

HIDDEN IDENTITY (N S Batchameah) did not get a clear run in the final 100m.

Jockey B Fayd'herbe (SHESH BESH) has been reprimanded for allowing his horse to shift outwards in the concluding stages of the race and going across FORT MCHENRY (G D Aucharuz).

At the start, BLEU ROYALE (P Mogun) made contact with HIGH VOLTAGE (J Da Silva).

Jockey G D Aucharuz (INSTINCTIVE POWER) was observed to have used his whip in consecutive strides before the 100m. He was found in contravention of Rule 147(6)(a)(i), in that, he admitted to have struck the horse, INSTINCTIVE POWER, more than once on consecutive strides in the running and signed an admission of guilt. Consequently, a penalty of Rs 3000 was imposed on him.
