2. ARBITRATOR (N. Marday) was awkward at the crossing at the 450m, shifted out, carrying MASSIMO (B. Ecoignard) and ALASKAN NIGHT (S. Rama) wider.

2. MAYENNE (K. Ramsamy) was awkward in its running over the 1000m crossing.
3. Jockey B. Bhaugeerothee (LIVERPOOL CHAMP) was found in contravention of Rule 29.2.13, in that, he had struck his horse more than 7 times prior to the 150m. Consequently, he has been issued with a reprimand.
